## F.A.I.R. PROGRAM 2022-2023 REQUEST FOR FUNDING

# CREATION OF A FUND RESERVED FOR EXPENSES RELATED TO THE HOLDING OF AN ELECTION

WHEREAS the Act to amend the Act respecting elections and referendums in municipalities, the Municipal Ethics and Good Conduct Act and various legislative provisions (LQ2021, c. 31) («Bill 49») came into force on November 5, 2021;

WHEREAS as of January 1, 2022, municipalities must establish, according to articles 278.1 and 278.2 of the *Act respecting elections and referendums in municipalities* (ARERM), a fund reserved for financing expenses related to the holding of an election;

**WHEREAS** the council must foresee, in accordance with the law, to annually allocate the necessary amounts to this fund for the next general election;

### **THEREFORE**

R2022-074

It is proposed by Johanne Clark Seconded by Kathy Burke And unanimously approved by the Councillors present

**TO** create a fund reserved for financing the expenses regarding the holding of an election.

**THAT** this fund will be composed of the sums allocated annually by the council, according to article 278.2 of the *Act respecting elections and referendums in municipalities* (ARERM).

## ALLOCATION OF A SUM TO THE FUND RESERVED FOR EXPENSES RELATED TO THE HOLDING OF AN ELECTION

**WHEREAS** 

through resolution R2022-074, the Municipality has, in accordance with article 278.1 of the *Act respecting elections and referendums in municipalities*, constituted a fund reserved for financing expenses related to the holding of an election;

**WHEREAS** 

pursuant to article 278.2 of the ARERM, the council must, after consulting with the Returning Officer, annually allocate the necessary amounts to this fund so that it is sufficient in the year that the next general election must be held in order to cover the costs of this election;

**WHEREAS** 

the cost of the next general election is presumably equal to the cost of the last general election or the one before it, whichever is greater, subject to the specific measures provided for in the Act for the 2021 general election (which is not to be taken into account);

**WHEREAS** 

in accordance with the Act and after consulting with the Returning Officer, the council hereby allocates an amount of \$8, 802.00 to this fund;

## **THEREFORE**

**TO** allocate an amount of \$2, 200.50 to the fund reserved for the expenses regarding the holding of an election for the 2022 fiscal year.

**THAT** the necessary funds allocated shall be transferred from the accumulated surplus of the Municipality of Grosse Ile for the 2022 fiscal year.

**THAT** the annual amount of \$2, 200.50 to be allocated to this fund for the 2023, 2024 and 2025 fiscal years shall be taken from the general fund of the Municipality of Grosse Ile and foreseen in the annual budget for each of the aforementioned years.

# CALL FOR TENDERS GEOTECHNICAL STUDY – CHEMIN WIDE

two (2) areas have been identified as problematic on Chemin Wide and will require further study in order to carry out the planned roadworks;

it has been recommended by the engineers at the FQM that a geotechnical study be carried out on Chemin Wide in order to determine the most sustainable manner to proceed with the roadworks;

**THAT** the Municipality of Grosse Ile shall proceed with a transfer of funds from its accumulated surplus in order to cover the cost of the geotechnical study.
