employee in the building at all time.

PROJECT FOR FUNDING

WHEREAS the community based organization of Grosse Ile

need adapted spaces and equipment to maintain

activities to dynamize our municipality;

WHEREAS for a financial matter, the Municipality wish to

concentrate investments and maintenance in

fewer buildings;

WHEREAS major investment were made at the 1, Jerry in

past years, when other buildings would need even more investment to be put back in good shape;

WHEREAS the 1 Jerry is a big building with a lot of space

(including the garage) but needs to be reorganized and updated to suit organizations and citizen's

needs.

THEREFORE

THAT the Municipality of Grosse-Ile submit the project of investment: Facilities of the Community Center. The maximum cost of this project should be \$155,000 and funding from the Municipality of \$5,000. An amount of a maximum of \$100,000 will be asked to the *Cadre de vitalisation*.

SEAT 4 OF THE MUNICIPAL COUNCIL – RESIGNATION LETTER

The returning officer, in accordance with article 316 of the *Loi sur les élections et les référendums dans les municipalités*, submits the letter of resignation of Mrs. Katrina Keating, as councillor – seat 4 dated August 22nd, 2024. Mrs. Keating's resignation will be effective September 1st, 2024.

In addition, she informs the municipal council of the vacancy of the seat 4, in accordance with article 333 of the *Loi sur les* élections et les référendums dans les municipalités,

Finally, as per article 339 of the *Loi sur les élections et les référendums dans les municipalités*, she sets polling day at November 17, 2024 for the election to the election of seat 4.

INSURANCE COVERAGE FOR THE MUNICIPAL INSPECTOR

WHEREAS

the current Municipal Inspector, Judith Landry, is hired under contract and is therefore not automatically covered by the municipality's insurance as a regular employee;

WHEREAS the municipal council wishes to insure the current

Municipal Inspector has the same insurance

coverage as the rest of the employee;

WHEREAS although Judith Landry has her own insurance, it

is important that she be properly covered for her actions and decisions taken on the territory of

Grosse Ile
